**AN ORDER CREATING THE DAVAO CITY PROGRAM MANAGEMENT AND  
IMPLEMENTING UNIT FOR THE PERFORMANCE CHALLENGE FUND**

**WHEREAS**, THE Performance Challenge Fund (PCF) is being granted by the Department of Interior and Local Government (DILG) in collaboration with the Department of Budget and Management (DBM) as an incentive for the performance of local government units (LGUs), particularly in the adoption of "Good Local Governance" in the areas of: (1) Good Financial Housekeeping, (2) Disaster Preparedness (3) Social Protection (4) Business Friendliness and Competitiveness (5) Peace and Order, and Environmental Management;

**WHEREAS**, in the year 2016, the City Government of Davao (City Gov't.) was granted said fund amounting to three million four hundred thousand pesos (PhP3,400,000.00) as it was awarded by the national government, through DILG, the "Seal of Good Local Governance;"

**WHEREAS**, this project is in line with the City Government of Davao's effort to assist in raising the standard of learning paraphernalia for students in all subject areas through the provision of E-Classroom Building and computer packages. The Emilio Ramos National High School was being chosen as beneficiary of the 2016 PCF financial award;

**WHEREAS**, it is now the intention of the City Government to utilize the 3.4 Million PCF granted to it for the construction of 1-storey school computer laboratory building (a floor area of 7 m x 9 m and equipped with eighteen (18) units of computer) at E. Ramos National High School (NHS), Diamond Village Avenue, Brgy. Angliongto, Buhangin District, Davao City;

**WHEREAS**, in order to ensure efficient utilization of the said PCF, it is necessary to create a specific unit who shall oversee not only its utilization, but also the successful operation of the School Computer Laboratory;

**NOW THEREFORE, I, SARA Z. DUTERTE**, Mayor of the City of Davao, by virtue of the power vested in me by law, do hereby order the following:

**SECTION 1. CREATION.** There is hereby created the **DAVAO CITY PROGRAM MANAGEMENT AND IMPLEMENTING UNIT FOR THE PERFORMANCE CHALLENGE FUND (PMIU)**, and the same shall be composed by the following persons and/or heads of the following offices, to wit:

**SECTION 2. DUTIES AND FUNCTIONS** – The PMIU shall have the following duties and functions:

1. Formulate plans for the judicious utilization and efficient implementation of the P 3.4 Million PCF, specifically for the successful construction and operation of the school computer laboratory;
2. Coordinate, facilitate, assist and monitor the recipient of the School Computer Laboratory, aid them to properly operate the said school facility;
3. Serve as the Program Facilitator and Coordinator of the City Gov't with the national agencies such as DILG and DBM;
4. Through the Unit Head, call or conduct for meetings as the need arises;
5. Periodically assess the overall efficacy of the use of the fund and the operations of the School Computer Laboratory; and
6. Prepare and submit reports to the City Mayor, DILG and any other government offices to which they will be required.

**SECTION 3. SECRETARIAT.** The Assistant Unit Head is hereby designated as the Head of the Secretariat of the PMIU, and shall be primarily tasked to handle all of its administrative, documentation and clerical functions.

The City Administrator is hereby directed to issue appropriate memoranda for identifying other City Government Employees to compose the Secretariat.

**SECTION 4. FUNDING/ OPERATING COSTS.** – All costs pertaining to the operation of PMIU shall be taken from the available funds of the City Government subject to the usual accounting and auditing rules and regulations.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 6. REPEALING CLAUSE.** All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 7. EFFECTIVITY.** This Executive Order shall take effect immediately.








