**AN ORDER IMPLEMENTING THE CREATION OF THE CITY CORE PLANNING TEAM (CCPT) OF THE PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP)**

**WHEREAS**, Davao City is one of the participating cities of the Philippine Rural Development Project;

**WHEREAS**, Davao City is about to implement its first Investment in Rural Enterprise and Agriculture and Fisheries Productivity and sub-project: Rehabilitation and Construction of Puroks 4, 6 and 8 Brgy. Subasta Farm to Market Road;
