AN ORDER CREATING A TECHNICAL WORKING GROUP (TWG) TO FACILITATE THE PROCESS OF DESILTING OPERATIONS IN THE RIVERS AND STREAMS IN THE WATERSHED AREAS OF DAVAO CITY

WHEREAS, Ordinance No. 0333-15 Series of 2015, provide for the creation of a Technical Working Group (TWG) who shall be responsible for all desilting operations in all rivers and streams within the watershed areas where such operations are needed;

WHEREAS, there is a need to allow desilting operations within the watershed areas, to address the heavy siltation problem in the rivers and streams which could result to the overflowing of water and flooding during rainy seasons;

NOW, THEREFORE, I, **SARA Z. DUTERTE,** Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION OF A TECHNICAL WORKING GROUP (TWG) TO FACILITATE THE PROCESS OF DESILTING OPERATIONS IN THE RIVERS AND STREAMS IN THE WATERSHED AREAS OF DAVAO CITY. There is hereby created a technical working group to facilitate the process of desilting operations in the rivers and streams in the watershed areas of Davao City.

SECTION 2. COMPOSITION. The Technical Working Group shall be composed as follows:

Members

- : 1. Department of Public Work and Highways
 - 2. Davao City Mining Regulatory Board
 - 3. Mines and Geosciences Bureau
 - 4. City Environment and Natural Resources Office

SECTION 3. DUTIES AND FUNCTIONS. The Technical Working Group shall perform the functions as follows:

- 1. Responsible for all desilting operations in all rivers and streams within the watershed areas of Davao City;
- 2. Determine the need for the desilting operation, the amount or volume of materials to be extracted during the desilting process;

.-3. Determine a private entity to conduct the desilting process operations in the event that the local government lacks the necessary equipment and manpower to conduct the de-silting operation;

SECTION 4. FUNDING/OPERATING COSTS - All costs pertaining to the operation of the Technical Working Group shall be taken from the available funds of the City Government of Davao subject to the usual accounting and auditing rules and regulations.

SECTION 5. SEPARABILITY CLAUSE. If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified.
