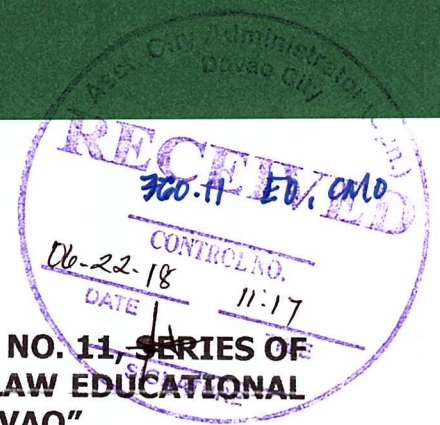

"AN ORDER AMENDING SECTION 3 OF EXECUTIVE ORDER NO. 11, SERIES OF 2017, COVERING THE BENEFITS FOR THE MEDICAL AND LAW EDUCATIONAL ASSISTANCE PROGRAM OF THE CITY GOVERNMENT OF DAVAO"

WHEREAS, the City Government of Davao gives utmost importance to education, thus providing financial assistance to indigent students who yearn to study in the fields of law and medicine is necessary;

WHEREAS, Section 3 of Executive Order No. 11, Series of 2017, amended Section 4 of Executive Order No. 7, Series of 2014, specifically the Scholarship Benefits for the Medical and Law Educational Assistance Program of the City Government of Davao;

WHEREAS, in the City Government's desire to further expand the coverage of the Medical and Law Educational Assistance Program, there is a need to amend Section 3 of Executive Order No. 11, Series of 2017 in order to cater to more students and provide full and half scholarship benefits to suitable and deserving applicants;

NOW THEREFORE, I, SARA Z. DUTERTE, Mayor of the City of Davao, by virtue of the power and authority vested in me by the law, do hereby order the amendment of Section 3 of Executive Order No. 1, Series of 2017, as follows:

Section 1. AMENDMENT OF SECTION 3 OF EXECUTIVE ORDER NO. 11, SERIES OF 2017

Section 3 of Executive Order No. 11, Series of 2017 amending Section 4 of Executive Order No. 7, Series of 2014 on the Scholarship Benefits for Medical and Law Educational Assistance Program, shall be read as follows:

"For Medical Educational Assistance:

Grantees will receive and be entitled to a full or half scholarship consisting of tuition fees, miscellaneous fees, book fees, and other fees that may be assessed by the medical school not exceeding One Hundred Sixty Thousand Pesos (Php 160,000.00) per semester for full scholars and Eighty Thousand Pesos (Php 80,000.00) for half scholars.

For Law Educational Assistance:

Grantees will receive and be entitled to a full or half scholarship consisting of tuition fees, miscellaneous fees, book fees, and other fees that may be assessed by the law school not exceeding Fifty-Eight Thousand Pesos (Php 58,000.00) per semester for full scholars and Twenty-Nine Thousand Pesos (Php 29,000.00) for half scholars.

The determination as to who will be granted full or half scholarship shall rest solely upon the discretion of the City Mayor based on the financial needs of the applicant."

Section 2. SEPARABILITY CLAUSE.

If, for any reason, any part or provision of this Executive Order is declared invalid or unconstitutional, any part or provision not affected thereby shall remain in full force and effect.

Section 3. EFFECTIVITY.

This order shall take effect immediately and shall remain in full force and effect unless otherwise revoked or amended.
