EXECUTIVE ORDER NO. 28
Series of 2018

AN ORDER CREATING A TECHNICAL WORKING GROUP TO ASSESS AND EVALUATE THE NEED FOR THE INSTALLATION OF ADDITIONAL STREET LIGHTS TO THE EXISTING STREET LIGHTING FACILITIES WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF DAVAO.

WHEREAS, with the ongoing infrastructure projects and road network expansion in the city, the demand for the installation of streetlight is increasing;

WHEREAS, in many instances, Barangay Officials and concerned residents of Davao City have been requesting for the installation of additional streetlights in their locality;

WHEREAS, the City Government of Davao recognizes the need to enhance the right of the people for provision of efficient streetlighting standards in all areas in the City of Davao;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 18 of the same code provides that Local Government Units shall have the power and authority to establish an organization that shall be responsible for the efficient and effective implementation of their development plans, program objectives and priorities;

NOW THEREFORE, for the best interest of public service, I, **SARA Z. DUTERTE**, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION. There is hereby created a Technical Working Group ("TWG" for brevity) and the same shall be composed of the following:

- Chairperson : City Mayor or her duly authorized representative
- Vice-Chairperson : City Administrator or her duly authorized representative
- Members : City Planning and Development Coordinator or his duly authorized representative
: City Engineer or his duly authorized representative
: City Information Technology Office-Head or his duly authorized representative

- : Barangay Cultural Communities Affairs and Development-Head or his duly authorized representative
- : City Accountant's Office or her duly authorized representative

The members of the TWG are hereby directed to name their respective permanent alternate representative who shall take their place in case of their absence.

SECTION 2. SUPPORT STAFF. In order to ensure that TWG is effective in the performance of its functions, it is hereby authorized to organize and constitute its Support Staff or Technical Staff to be composed of employees from the different offices of the City Government.

SECTION 3. FUNCTIONS. The TWG shall have the following tasks and functions:

1. Responsible for mapping out the plan of action relative to the installation of additional street lights in the City of Davao.
2. Assess, evaluate and recommend the feasibility of street lights installation in the area in terms of road safety, security and well-being of the general public.
3. Inspect and ensure that all street lights are functioning.

SECTION 4. OPERATIONAL EXPENSES. Such amount as may be necessary for the effective operation of the TWG is hereby authorized to be appropriated and allotted subject to the usual government accounting and auditing rules and regulations.

SECTION 5. EFFECTIVITY. This order shall take effect immediately.
