**EXECUTIVE ORDER NO. 22**  
Series of 2020

**A DECLARATION AND ORDER FOR THE SUSPENSION OF ALL DOMESTIC AIR TRAVEL TO AND FROM DAVAO CITY**

**WHEREAS**, the World Health Organization declared a pandemic on the spread of the Covid19 virus infection;

**WHEREAS**, President Duterte issued Presidential Proclamation 922 to put the country in a State of Public Health Emergency in relation to National Security;

**WHEREAS**, President Duterte issued Presidential Proclamation 929 and declared a State of Calamity in the entire country for a period of six months;

**WHEREAS**, the Covid19 IATF issued Resolution 11 allowing LGUs to declare a community quarantine under specific parameters;

**WHEREAS**, the Epidemiologists and Infectious Disease Specialists are unable to estimate when the acceleration phase of the Covid19 will happen and when it can be controlled;

**WHEREAS**, there is a need to extend the suspension of Domestic Air Travel to and from Davao City;

**NOW, THEREFORE, I, SARA Z. DUTERTE**, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the suspension of all domestic air travel to and from Davao City at the Davao International Airport until after the State of Public Health Emergency and State of Calamity is lifted or unless sooner withdrawn with recommendation from the Epidemiologists and Infectious Disease Specialists.

**SECTION 1.** Section 1 of Executive Order No. 18 Series of 2020 is hereby reiterated in this order as follows:

*SECTION 1. EXEMPTION OF CERTAIN INTERNATIONAL AND DOMESTIC AIR TRAVEL TO AND FROM DAVAO CITY. The following international and domestic air travel to and from Davao City shall be exempted from the coverage of Executive Orders No. 12 and 13:*

- A) Cargo Flights*
- B) Medical Evacuations (Air Ambulance)*
- C) Weather Mitigation Flights*
- D) Maintenance Flights*

E) *Government and Military Flights*

F) *For emergency landing:*

- *All crews and passengers will not disembark as much as possible;*
- *If disembarkation is needed, crews and passengers will be contained in an isolation room in the airport.*

G) *Recovery flights for expatriates – provided that each flight is subject to prior clearance by the City Government of Davao*

**SECTION 2. SEPARABILITY CLAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.


**SECTION 3. REPEALING CLAUSE.** All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 4. EFFECTIVITY.** This order shall take effect immediately.
