## **EXECUTIVE ORDER NO. 05**

Series of 2021

## AN ORDER EXTENDING UNTIL MARCH 31, 2021 THE LIQUOR BAN AND CURFEW WITHIN THE CITY

**WHEREAS,** the World Health Organization (WHO) has declared a COVID-19 pandemic;

**WHEREAS,** President Rodrigo Duterte issued Presidential Proclamation 1021 extending the State of Calamity in the country until September 12, 2021;

**WHEREAS**, there is a need to control the COVID-19 cases in Davao City because of the full occupancy of the COVID-19 beds in the Southern Philippines Medical Center (SPMC);

**WHEREAS**, the City shall remain under a General Community Quarantine (GCQ) status until February 28, 2021 per announcement of Presidential Spokesperson Harry Roque today;

**WHEREAS,** an order providing for the imposition of a curfew was implemented as provided in Executive Order No. 55-B s. 2020 to pre-empt the increase of cases during the holiday season, to support the Davao City Police Office (DCPO) in their anti-criminality effort and to intensify terrorism surveillance and anti-illegal drugs operations in the coastal areas;

**WHEREAS**, an order providing for the reimposition of a 24-hour liquor ban in Davao City was implemented as provided in Executive Order No. 59 s. 2020 to prevent the exposure of individuals to the COVID-19 virus by reason of their unbridled drinking sessions;

**WHEREAS**, an order providing for the extension of Executive Order Nos. 55-B and 59 was implemented as provided in Executive Order No. 71 s. 2020 effective until January 31, 2021;

**WHEREAS**, it becomes necessary to extend Executive Order No. 71 s. 2020 to regulate some activities that can contribute to local transmission in the City.

**NOW, THEREFORE, I, SARA Z. DUTERTE**, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. EXTENSION.** The effectivity of Executive Order No. 71 s. 2020 is hereby extended until March 31, 2021.

**SECTION 2. PENALTIES.** All existing applicable laws and ordinances shall be pursued against those who fail to follow the provisions of this Executive Order.



**SECTION 3. SEPARABILITY CLAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 4. REPEALING CLAUSE.** All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.


**SECTION 5. EFFECTIVITY.** This Order shall take effect from January 31, 2021 to March 31, 2021.
