EXECUTIVE ORDER NO. ひん Series of 2021

AN ORDER STRENGTHENING THE OFFICE FOR SENIOR CITIZENS AFFAIRS UNDER THE CITY MAYOR'S OFFICE

WHEREAS, Section 17 of the 1991 Local Government Code states that local government units shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities which include social welfare services for the elderly;

WHEREAS, Section 6 of Republic Act No. 9994, otherwise known as the Expanded Senior Citizens Act of 2010 mandates that an Office for Senior Citizens Affairs (OSCA) shall be established in all cities;

WHEREAS, City Ordinance No. 0417-10, Series of 2010, entitled "Older Persons Welfare Code of Davao City" directs that the City Mayor shall, through an Executive Order, create and constitute a joint Executive-Legislative Committee to formulate the Implementing Rules and Regulations to carry out the provisions of such code;

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of Davao City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION OF A JOINT EXECUTIVE-LEGISLATIVE COMMITTEE. A Joint Executive-Legislative Committee is hereby created and shall be composed of the following:

- 1. City Social Welfare and Development Office;
- 2. Office for the Senior Citizens Affairs;
- 3. City Health Office; and
- 4. Committee on Social Services, Sangguniang Panlungsod.

SECTION 2. FUNCTIONS OF THE COMMITTEE. The Committee shall draft the Implementing Rules and Regulations of City Ordinance No. 0417-10, Series of 2010, entitled "Older Persons Welfare Code of Davao City".

SECTION 3. SECRETARIAT. The Office for the Senior Citizens Affairs shall serve as the Secretariat tasked to handle all administrative and secretarial activities.

SECTION 4. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.



SECTION 5. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of the Executive Order are hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately.
