**EXECUTIVE ORDER NO. 14**  
Series of 2021

**"AN ORDER AMENDING SECTION 1 OF EXECUTIVE ORDER NO. 03 SERIES OF 2021 ENTITLED AN ORDER CREATING THE DAVAO CITY HIGH PRIORITY BUS SYSTEM PROJECT INTER-AGENCY TASK FORCE"**

**WHEREAS**, Section 2, paragraph (c) of Republic Act No. 7160 or the "Local Government Code of 1991" explicitly provides that it is the policy of the State that all national agencies and offices are required *"to conduct periodic consultations with appropriate local government units, nongovernmental and people's organizations, and other concerned sectors of the community before any project or program is implemented in their respective jurisdictions."*

**WHEREAS**, Section 25, paragraph (b) of the same Code further provides *"national agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects."*

**WHEREAS**, the City Government of Davao ("City Gov't." for brevity), in partnership with the national government, primarily the Department of Transportation ("DOTr" for brevity), are implementing the Davao Public Transport Modernization Project or the High Priority Bus System Project ("HPBS Project" for brevity);

**WHEREAS**, on January 25, 2021, Executive Order No. 03 Series of 2021 was issued creating the Davao City High Priority Bus System Project Inter-Agency Task Force;

**WHEREAS**, there is need to include additional members to the current membership of the Davao City High Priority Bus System Project Inter-Agency Task Force;

**NOW, THEREFORE, I, SARA Z. DUTERTE**, City Mayor of Davao, by virtue of the powers vested in me by law, do hereby order as follows:

**SECTION 1.** Section 1 of Executive Order No. 03 Series of 2021 is hereby amended to read as follows:

**SECTION 1. CREATION AND COMPOSITION.** There is hereby created the **DAVAO CITY HIGH PRIORITY BUS SYSTEM PROJECT INTER-AGENCY TASK FORCE** ("TF HPBS" for brevity), and the same shall be composed by the following persons and/or heads of the following offices, to wit:

**Chairperson** : Office of the City Mayor  
**Co-Chairperson** : Department of Transportation – Region XI

All members of the TF HPBS are hereby directed to name their respective alternate and permanent representatives who shall take their place in case of their absence.

**SECTION 2. REPEALING CLAUSE.** All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
