**EXECUTIVE ORDER NO. 11**

**AN ORDER RECONSTITUTING THE COMMITTEE ON DECORUM AND INVESTIGATION (CODI) TO HANDLE SEXUAL HARASSMENT CASES IN THE CITY GOVERNMENT OF DAVAO**

**WHEREAS**, Section 4, paragraph (b) of RA 7677, otherwise known as the Anti-Sexual Harassment Act of 1995, mandates the creation of the Committee on Decorum and Investigation (CODI) to handle sexual harassment cases in both government and private sectors;

**WHEREAS**, pursuant to said mandate, the Committee on Decorum and Investigation in the City Government of Davao was created by virtue of Executive Order No. 13, series of 2002 and subsequently modified by Executive Order No. 09, Series of 2005;

**WHEREAS**, Section 3 of said Executive Order, provides that the term of office of the different members of the CODI shall not be more than two (2) years;

**WHEREAS**, the term of office of the existing members of the CODI has already expired, hence, the need to reconstitute the same;

**NOW, THEREFORE, I, SARA Z. DUTERTE**, Mayor of Davao City, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Committee on Decorum and Investigation in the City Government of Davao, as follows:

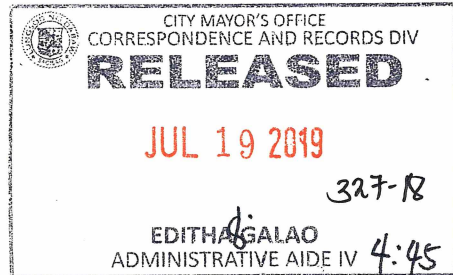
This Executive Order shall take effect immediately upon approval.
