**EXECUTIVE ORDER NO. 24**  
Series of 2019

**AN ORDER RECONSTITUTING THE MEMBERSHIP OF THE TASK FORCE ON THE INVENTORY OF REAL PROPERTIES OF THE CITY GOVERNMENT OF DAVAO AND REDEFINING ITS POWERS AND FUNCTIONS**

**WHEREAS**, Executive Order No. 30, Series of 1998, originally created and constituted the membership of the Task Force on the Inventory of the Real Properties of the City Government of Davao;

**WHEREAS**, Executive Order No. 12, Series of 2011, reconstituted the membership of the Task Force and redefined its powers and functions and was subsequently modified by Executive Order No. 36, Series of 2013;

**WHEREAS**, the said Task Force was organized for the purpose of identifying the real properties of the City Government of Davao held in absolute ownership or otherwise and those acquired by sale, prescription or donation including those reserved by the national government for specific purposes to and in favour of the then Municipal Government of Davao, now City Government of Davao or those placed under its management and/or administration.

**WHEREAS**, The Task Force is also responsible in facilitating the titling of the said real properties in the name of the City Government of Davao and to make appropriate recommendation to the City Mayor and/or the Sangguniang Panlungsod for the protection of its identified properties or for recovery of those properties illegally occupied by another;







**WHEREAS**, there is a need to further reconstitute the membership of the Task Force and redefine its powers and functions in order to ensure the effective and efficient performance of its functions and the attainment of its objectives;

**NOW, THEREFORE, I, SARA Z. DUTERTE**, Mayor of the City of Davao, by virtue of the power vested in me by law, do hereby order the reconstitution of the membership of the TASK FORCE ON THE INVENTORY OF REAL PROPERTIES OF THE CITY GOVERNMENT OF DAVAO, as follows:

**SECTION 1. ORGANIZATION.** The Task Force on the Inventory of Real Properties of the City Government of Davao shall be composed of the following:

**SECTION 2. TECHNICAL WORKING GROUP.** There shall be created a Technical Working Group to assist the Task Force in the discharge of its functions whose composition shall be determined by the members of the Task Force.

**SECTION 3. FUNCTIONS.** The Task Force shall perform the following functions:

1. Conduct research and inventory of all real properties of the City Government held in absolute ownership, commodatum (gratuitous use of a real property), usufruct, lease or otherwise and those acquired by sale, prescription, barter, donation, expropriation or other modes of acquiring ownership including those reserved by the National Government for specific purposes to and in favour of the then Municipal Government of Davao, now City Government of Davao through Presidential Proclamation or those placed under the management and/or administration;
2. Facilitate the titling of all identified real properties in the name of the City Government of Davao or secure an Owner's Duplicate Copy of Titles of properties where appropriate Certificates of Title are missing;
3. Make appropriate recommendation to the City Mayor and/or the Sangguniang Panlungsod for the preservation and protection of its identified properties or for the recovery of those properties illegally occupied by another;
4. Enlist the assistance and cooperation of concerned local and national government agencies, non-government organizations and other private entities and individuals to ensure efficiency in the discharge of its functions;
5. Submit a quarterly progress report to the Office of the City Mayor; and,
6. Perform such other functions as the Mayor may order from time to time.

**SECTION 4. FUNDING/OPERATING COSTS.** All costs pertaining to the operation of the Task Force on the Inventory of Real Properties of the City Government of Davao, including the payment of honoraria, incidental and other expenses to its members, and other appropriate personnel, as may hereinafter identified by the Chairperson or the Vice-Chairperson, shall be taken from the available funds of the City Government of Davao, subject to the usual accounting and auditing rules and regulations.

**SECTION 5. REPEALING CLAUSE.** All previous Executive Orders inconsistent with this Executive Order are hereby repealed or modified accordingly.

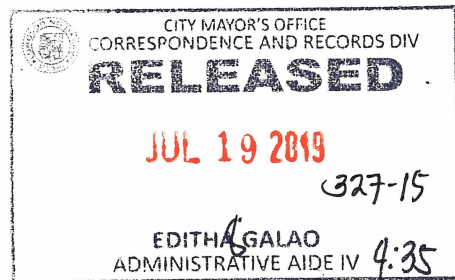
**SECTION 6. EFFECTIVITY.** This Executive Order shall take effect immediately.
