EXECUTIVE ORDER NO. 27

"AN ORDER RECONSTITUTING THE COMPOSITION OF THE LOCAL HEALTH **BOARD (LHB) OF DAVAO CITY"**

WHEREAS, Section 102, RA 7160, otherwise known as the Local Government Code of 1991, provides that there shall be established in every province, city or municipality a provincial, city or municipal health board;

WHEREAS, the is a need to reconstitute the membership of the Local Health Board of Davao City to facilitate the delivery of basic health services to its people aimed at improving the quality of life in the city's population;

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local Health Board (LHB), as follows:

SECTION 1. COMPOSITION. The membership of the LHB shall be composed of the following:

Chairperson 24/19 Vice-Chairperson Members

City Mayor Are 07 26 19 City Health Officer

1. Chairperson, SP Committee on Health

2. Department of Health Region XI

3. Representative from the private sector or non-governmental organization involved in health services in the city

In the exigency of public service and in case of absence of the Chairperson, the City Administrator shall assume the former's duties and functions in the LHB. All the above-named offices and/or persons named as members in herein section are also hereby directed to further name their alternate permanent representatives to the LHB who shall also take their place in case of their absence.

The Chairperson or her authorized representative shall identify appropriate personnel to comprise the technical staff of the LHB.

SECTION 2. FUNCTIONS. Pursuant to its mandate, the LHB shall exercise the following functions:

A. To propose to the Sangguniang Panlungsod, in accordance with the standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services in the city;

- B. Serves as an advisory committee to the Sangguniang Panlungsod on health matters such as, but not limited to, the necessity for and application of, local appropriations for public health purposes; and
- C. Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget reviews, operations review and similar functions.

SECTION 3. OPERATIONAL EXPENSES AND FUNDING. All members and personnel who are performing functions of the LHB are hereby authorized to claim for incidental expenses relative to the services rendered in addition to their duties and responsibilities and for work beyond office hours subject to the usual accounting and auditing rules and regulations chargeable against budgetary allocations of the LHB.

SECTION 4. REPEALING CLAUSE. All Executive Orders or issuances inconsistent with the provision of the Executive Order are hereby repealed, superseded or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This order shall take effect immediately.
