**"AN ORDER RECONSTITUTING THE PEOPLE'S LAW ENFORCEMENT BOARDS
IN DISTRICTS 1, 2 AND 3 OF DAVAO CITY"**

WHEREAS, Republic Act No. 6975 as amended by Republic Act No. 8551 and Department of Interior and Local Government Memorandum Circular No. 2002-010 provide, among others, the creation of the People's Law Enforcement Boards (PLEBs) in every city;

WHEREAS, DILG MC No. 98-116 provides for the reconstitution of local special bodies including the PLEBs in accordance with the Article 64 (e) of the Implementing Rules and Regulations of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Davao City has three (3) legislative districts which require the creation or reconstitution of its respective PLEBs.

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION/RECONSTITUTION. The People's Law Enforcement Board in each of the three (3) legislative districts of Davao City is hereby created and reconstituted and the same shall be composed by the following:

Section 2. FUNCTIONS, POWERS AND DUTIES. The PLEB through its respective members are primarily tasked to conduct hearing and adjudication of citizen complaints against uniformed members of the Philippine National Police for offenses committed in their area of jurisdiction. As such, the function, powers and duties of the People's Law Enforcement Board are those provided for in the following, to wit:

- a. Republic Act No. 6975, otherwise known as the Department of the Interior and Local Government Act of 1990;
- b. Memorandum Circular No. 91-002 of the National Police Commission;
- c. Republic Act No. 8551, other known as the Philippine National Police Reform and Reorganization Act of 1998;
- d. Department of Interior and Local Government (DILG) Memorandum Circular No. 2002-010 or the 'Revised RULES OF PROCEDURE IN THE HEARING AND ADJUDICATION OF CITIZEN'S COMPLAINTS AGAINST UNIFORMED MEMBERS OF THE PHILIPPINE NATIONAL POLICE (PNP) BEFORE THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB), "and;
- e. Other applicable laws, rules, regulations and issuances.

SECTION 3. TECHNICAL ASSISTANCE. The PLEB in each of the city's districts shall receive technical and administrative assistance from the DILG Davao City Office.

SECTION 4. BUDGET ALLOCATION. The City Government of Davao shall include in its Annual Budget or Supplemental Budget/s, as may become necessary, the corresponding per diems of the members of the PLEB and other allowable maintenance, operating and/or incidental expenses of the PLEB, subject to the usual accounting and auditing rules and regulations.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE – All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

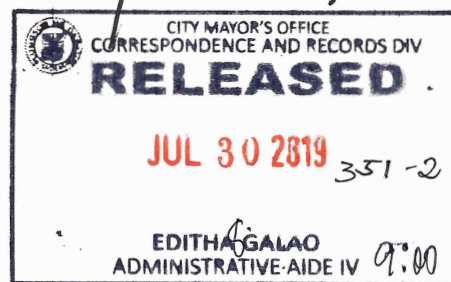
SECTION 7. EFFECTIVITY – This Executive Order shall take effect immediately.
