EXECUTIVE ORDER NO. 32

Series of 2021

AN ORDER CREATING THE COMMITTEE ON ANTI-RED TAPE (CART)

WHEREAS, Republic Act No. 11032, otherwise known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", mandates all government agencies to adopt simplified requirements and procedures that will reduce red tape and expedite business and non-business- related transactions;

WHEREAS, in compliance with such law, Executive Order No. 43, Series of 2020 was issued designating the Internal Audit Service Division as the Anti-Red Tape Unit of the City Government of Davao;

WHEREAS, the Anti-Red Tape Authority (ARTA) issued Memorandum Circular No. 2020-07 Series of 2020 directing all government offices to designate a Committee on Anti-Red Tape (CART) and providing the guidelines thereof;

WHEREAS, such circular instructs that agencies with existing unit to comply with the Anti-Red Tape Act of 2007 (R.A. No. 9485), as amended by R.A. 11032, should be reorganized as the CART.

NOW, THEREFORE, I, SARA Z. DUTERTE, City Mayor, this City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION. There shall be created a Committee on Anti-Red Tape and the same shall be composed of the following:

SECTION 2. FUNCTIONS. The CART shall ensure compliance with the requirements of R.A. No. 11032, its Implementing Rules and Regulations and subsequent issuances by the ARTA, as applicable.

SECTION 3. SECRETARIAT. The Internal Audit Service Division shall serve as the Committee's Secretariat tasked to handle all administrative and secretarial activities.

SECTION 4. FUNDING AND OPERATING COSTS. All costs pertaining to the operations of the Committee shall be chargeable against available funds and resources of the local government, subject to the usual accounting and auditing rules.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.


SECTION 6. REPEALING CLAUSE. All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately.
