EXECUTIVE ORDER NO. 36
Series of 2019

AN ORDER CREATING THE CITY INTER-AGENCY COMMITTEE ON INDIGENOUS PEOPLE'S HEALTH (CIAC-IPH) PURSUANT TO JOINT MEMORANDUM CIRCULAR NO. 2015-0035.

WHEREAS, as provided in Article III, Section 15 of the 1987 Constitution; It is among the policies of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, as stated further in Article XIII, Section 11 of the 1987 Constitution; "The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people at affordable cost. There shall be priority for the needs of the under-privileged sick, elderly, disabled, women and children";

WHEREAS, Section 455 (b), [2], of the Local Government Code, provides that for efficient and economical governance, the purpose of which is the general welfare of the City and its inhabitants pursuant to Section 16, which states that the City Mayor shall enforce all laws and ordinances relative to the governance of the city and in the exercise of the appropriate corporate powers provided for under Section 22: Implement all approved polices, programs, projects, services and activities of the city;

WHEREAS, in pursuit of Universal Health Care especially among the disadvantaged groups, the Department of Health (DOH), National Commission on Indigenous People (NCIP), and the Department of Interior and Local Government (DILG) issued the Joint Memorandum Circular No. 2013-01 dated 19 April 2013, entitled "Guidelines on the Delivery of Basic Health Services for Indigenous Cultural Communities/Indigenous Peoples (ICCs/IPs.);

WHEREAS, the circular aims to set the guidelines that will address access, utilization, coverage, and equity issues in the provision of basic health services for ICCs/IPs to achieve better health outcomes;

WHEREAS, pursuant to the Joint Memorandum Circular (JMC), the NCIP, DOH and, DILG will be the main implementing agencies and shall oversee the implementation and monitoring activities within the JMC and its strategic plan;

WHEREAS, the creation of an inter-agency committee at the national, regional, and city levels shall be organized to oversee the planning, implementation, monitoring, and evaluation of the guidelines set within the JMC;

NOW THEREFORE, by virtue of the powers vested in me by the Constitution and existing laws, **I, SEBASTIAN Z. DUTERTE**, Acting City Mayor of Davao City, do hereby ORDER AND DIRECT the following:

SECTION 1. TITLE. This Executive Order shall be known as the City Inter-Agency Committee on Indigenous Peoples' Health (CIAC-IPH) of Davao City.

SECTION 2. COMPOSITION OF THE CITY INTER-AGENCY COMMITTEE ON INDIGENOUS PEOPLES' HEALTH. The CIAC-IPH Team is hereby created and constituted as follows:

SECTION 3. FUNCTIONS AND RESPONSIBILITY OF THE CIAC-IPH. The Committee shall have the following functions and responsibilities:

1. To oversee the planning, implementation and monitoring, and evaluation of the guidelines set within the JMC; and
2. To carry out the implementation arrangements of the JMC that will address access, utilization, coverage, and equity issues in the provision of basic health services for ICCs/IPs to achieve better health outcomes.
3. May invite other program stakeholders from the Government Agencies (local and national), Non-Government Organizations, and Private Sectors for assistance as circumstances may require;
4. Serve as technical coordinating and monitoring arm in the implementation of the JMC and its strategic plan at the city level;
5. Monitor the implementation of all plans, programs, and projects at the City level;

6. Provide regular feedback/status report on progress of the implementation and policy recommendations to Regional Inter-Agency Committee.

SECTION 4. SECRETARIAT. The City Health Office shall serve as the CIAC – IPH Secretariat. The secretariat performs the following functions:

1. Documents/Records/Keeps minutes of meetings of the CIAC-IPH;
2. Coordinates the implementation of the CIAC-IPH plans and activities;
3. Serves as the center of communication;
4. Provides reports to the CIAC-IPH;
5. Performs other secretariat functions as may be assigned by the Chairperson of CIAC-IPH

SECTION 8. FUNDING. The budget appropriation shall be charged against the general fund of the CHO and additional funds from other national and local agencies, such amount necessary for the implementation of this JMC, and other strategic plans provided by member agencies, subject to the budgetary, accounting and auditing rules and regulations.

SECTION 9. SEPARABILITY CLAUSE. If, for any reason, any part or provision of this Executive Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 10. EFFECTIVITY. This Executive Order shall take effect immediately. It shall remain effective unless sooner revoked or modified.

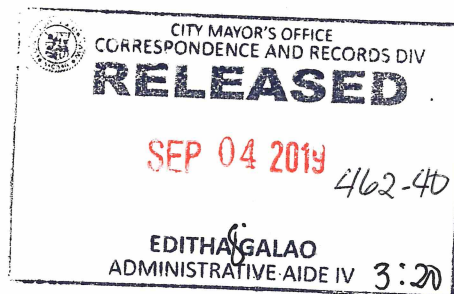
