AN ORDER CREATING THE DAVAO HISTORY BOOK COUNCIL AND THE TECHNICAL WORKING GROUP (TWG) AS MANDATED BY ORDINANCE NO. 0330-20, SERIES OF 2020

WHEREAS, Ordinance No. 0330-20, Series of 2020 entitled "An Ordinance Requiring all Public and Private Schools in all Levels in Davao City, to include in their curriculum the Teaching of the History in the City of Davao" is the basis for this Executive Order;

whereas, it is the policy of the City of Davao to promote character formation and wholesome personality development by requiring schools at the elementary, secondary, and tertiary levels to inculcate patriotism and nationalism, foster love of humanity, respect for human rights, appreciation of the role of national heroes in the historical development of the country, teach the rights and duties of citizenship, strengthen ethical and spiritual values, and develop moral character and personal discipline. Thus, culture and tradition, and history of the city will now be an integral part in the education of our students in Davao City;

WHEREAS, while there are several books about Davao history by various authors, there has been no attempt to write a comprehensive history of Davao City that could serve as an instructional material for the use of schools taking into consideration some pedagogical principles of instruction;

WHEREAS, the inclusion of the teaching of the Davao History in the school curriculum is expected to instill the Davaoeños' understanding and appreciation of the City's diverse culture, its traditions and values, the people and leaders who shaped Davao's identity, making the city pride itself on its symbolic slogan, "Life is Here";

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by laws, do hereby order the following:

SECTION 1. CREATION OF THE DAVAO HISTORY BOOK COUNCIL. There is hereby created a Davao History Book Council to be headed by the City Mayor for the purpose of managing and implementing the project.

SECTION 2. COMPOSITION OF THE DAVAO HISTORY BOOK COUNCIL. The Davao History Book Council shall be composed of:

- Vice Mayor

- SP Chairperson, Committee on Education, Science and Technology, Culture and Arts
- Head, City Planning and Development Office

The Council shall serve as the policy-making body for this project and shall officially approve the final works of the Technical Working Group.

SECTION 3. THE TECHNICAL WORKING GROUP. The Technical Working Group (TWG) of the Davao History Book Council shall be composed of the following:

- 1. Two (2) members from the City Council
- 2. Four (4) representatives from the Division of City Schools (The assigned Superintendent of the Division of City School and three others)
- 3. One (1) representative from the City Planning Office
- 4. One (1) representative from the City Library
- 5. One (1) representative from the Museo Dabawenyo
- 6. Three (3) authors of Davao History Books

 - Bro. Karl M. Gaspar
 - Dr. Ricardo M. de Ungria
- 7. Two (2) representatives from the Davao Historical Society
 - Ms. Amalia Montecillo Bandiola
 - Ms. Patricia Melizza B. Ruivivar
- 8. Two (2) representatives from the DepEd Regional Office XI
 - Regional Director Dr. Allan G. Farnazo
 - Asst. Regional Director Maria Ines C. Asuncion

SECTION 4. FUNCTIONS OF THE TECHNICAL WORKING GROUP (TWG) are as follows:

- To undertake wide-spread consultation with the different sectors of the Davao community such as but not limited to the academe, business, media, indigenous people, youth, public officials, pioneer families, authors of history books, artists, etc.
- 2. To undertake research and other studies in collaboration with concerned groups;
- 3. To prepare learning materials or modules for instructional purposes;
- 4. To come up with an official "Davao City History" book copyright by the City Government of Davao;
- To prepare a budget for one working year and to recommend additional workers or contract of service personnel, if necessary, to get the work load done;

SECTION 5. BUDGET. There shall be a budget allocated from available and appropriate sources to fund the operation and activities of the Technical Working Group (TWG) including administrative cost, subject to the usual accounting and auditing rules and regulations.

SECTION 6. REPEALING CLAUSE. All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.






