**"AN ORDER RECONSTITUTING THE COMPOSITION OF THE LOCAL HEALTH BOARD (LHB) OF DAVAO CITY"**

**WHEREAS**, Section 102, R.A. 7160, otherwise known as the Local Government Code of 1991, provides that there shall be established in every province, city or municipality a provincial, city, or municipal health board;

**WHEREAS**, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare of its constituents;

**WHEREAS**, Section 3, R.A. 11223, otherwise known as the Universal Health Care Act, was promulgated to progressively realize universal health care in the country through a systemic approach and clear delineation of roles of key agencies and stakeholders towards better performance in the health system and a people-oriented approach for the delivery of health services that is centered on people's needs and well-being, and cognizant of the differences in cultures, values, and beliefs;

**WHEREAS**, there is a need to reconstitute the membership of the Local Health Board of Davao City in order for it to be aligned with the objectives of the Universal Health Care Act by adding members from various sectors of the society who will help facilitate the delivery of basic health services to its people aimed at improving the quality of life in the city's population;

**NOW, THEREFORE, I, SARA Z. DUTERTE**, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local Health Board (LHB), as follows:

**Section 1. COMPOSITION** – The membership of the LHB shall be composed of the following:

In the exigency of public service and in case of absence of the Chairperson, the City Administrator shall assume the former's duties and functions in the LHB. All the above-named offices and/or persons names as members in herein section are also hereby directed to further name their alternate permanent representative to the LHB who shall also take their place in case of their absence.

The Chairperson or her authorized representative shall identify appropriate personnel to comprise the technical staff of the LHB.

**Section 2. FUNCTIONS.** Pursuant to its mandate, the LHB shall exercise the following functions:

- a) To propose to the Sangguniang Panlungsod, in accordance with the standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services in the City;
- b) To serve as an advisory committee to the Sangguniang Panlungsod on health matters such as, but not limited to, the necessity for and application of, local appropriations for public health purposes, and;
- c) To coordinate consistently with the technical and administrative standards of the Department of Health, create committees which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget reviews, operations review, and other similar functions.

**Section 3. OPERATIONAL EXPENSES AND FUNDING.** All members and personnel who are performing functions of the LHB are hereby authorized to claim for incidental expenses relative to the services rendered in addition to their duties and responsibilities ad for the work beyond office hours subject to the usual accounting and auditing rules and regulations chargeable against budgetary allocations of the LHB.


**Section 4. REPEALING CLAUSE.** All Executive Orders or issuances inconsistent with the provisions of the Executive Order are hereby repealed, suspended, modified accordingly.

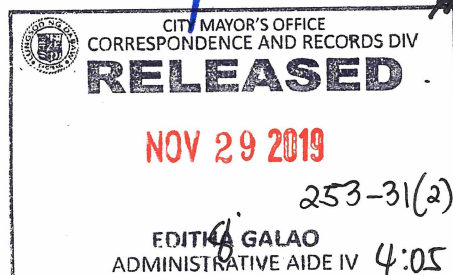

**Section 6. EFFECTIVITY CLAUSE.** This Order shall take effect immediately.
