AN ORDER INTEGRATING PRESIDENTIAL EXECUTIVE ORDER NO. 70, SERIES OF 2018 PROMULGATED BY PRESIDENT RODRIGO ROA DUTERTE AND ITS IMPLEMENTING GUIDELINES INTO THE PEACE 911, PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES

WHEREAS, prior to the issuance of EO 70, the City Government of Davao has long engaged into peacebuilding through its Davao City Advisory Committee on Peace and Development ("DC PEACE-DEV") created by virtue of Executive Order No. 45, Series of 2017 and Task Force Peace 911 of Davao City created by virtue of Executive Order No. 12, Series of 2018;

WHEREAS, DC PEACE-DEV conducted community consultations called "*panag-ambit*" in pilot barangays and as a result thereof, programs for peacebuilding processes in focus areas were devised as part of the committee's duty to create solutions to identified concerns within this jurisdiction;

WHEREAS, after its creation, Task Force Peace 911 of Davao City implemented peacebuilding efforts, programs, and measures to prioritize and harmonize the delivery of basic services and social interventions to the focus areas;

WHEREAS, with the positive gains in the implementation of these peacebuilding efforts there is a need to align and harmonize Davao City's EO No. 45 Series of 2017 and EO No. 12 Series of 2018 with EO 70 to institutionalize the convergence of efforts among agencies and stakeholders within this jurisdiction;

WHEREAS, DC PEACE-DEV and Task Force Peace 911 of Davao City shall now be known as Peace 911;

NOW, THEREFORE, I, SARA Z. DUTERTE, City Mayor, this City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COVERAGE OF PEACE 911. Peace 911 shall spearhead the peacebuilding program of the City Government for the entire City of Davao.

SECTION 2. CREATION AND COMPOSITION OF GENERAL COMMITTEE.

There is hereby created a Peace 911 General Committee which shall be the policymaking body of Peace 911, to be composed of the following:

1. Chairperson
2. 2 Members from the Government
3. 2 Members from the Private Sector
4. 1 Member from a Faith Based Organization
5. Head of the Secretariat and Focal Person

All of the above committee members shall be appointed by the City Mayor by way of a memorandum.

SECTION 3. FUNCTIONS OF THE PEACE 911 GENERAL COMMITTEE.

In addition to the functions of Davao City Peace-Dev as laid out in EO No. 45, the provisions of Section 4 EO 70 shall form part of the functions of the Peace 911 General Committee. The Peace 911 General Committee shall develop the Davao City Peace Framework from which all peacebuilding programs shall be implemented. The local framework shall be aligned to the National Peace Framework in so far as it is applicable to the local situation.

SECTION 4. APPOINTMENT OF FOCAL PERSON, CLUSTER COORDINATORS AND CREATION OF BARANGAY PEACE 911 (BP 911).

1. There shall be a "Focal Person", which is also the Head of the Secretariat;
2. There shall be a Cluster Coordinators for clustered barangays;
3. The Barangay Peace 911 ("BP 911") shall serve as the peace coordinators in their respective barangays.
4. BP 911 shall be composed of the Punong Barangay, Barangay Secretary, Representative from each of the following sectors, namely, the organization of farmers, Indigenous Peoples Community, Faith-based Organization, Youth and Women Sector.
5. Subject to the availability of funds and applicable COA Rules and Regulations, additional staff may be hired when the need arises.

SECTION 5. FUNCTIONS OF HEAD OF SECRETARIAT AND FOCAL PERSON.

1. Serve as the gatekeeper of all programs and projects to be implemented within the focus areas, and as such, shall coordinate all efforts and initiatives to the involved communities, government agencies concerned and/or to the prospective project proponents, as may be necessary, in order to effectively manage and smoothly carry out these programs, and at the same time sustain peace in this city;

2. Serve as the implementing arm for all initiatives embodied under the peacebuilding program designed by the Peace 911 General Committee for the City of Davao, as may be approved by the City Mayor;
3. Create a single channel (convergence) for all services, programs and activities that shall be introduced to the focus areas;
4. Report any concerns and issues which may arise, from time to time, to the City Mayor and recommend counter-measures; and
5. Perform such other acts to ensure the implementation of the Whole-of-Nation approach of the national government.

SECTION 6. SUPPORT OFFICES FOR PEACE 911. The following offices are hereby tasked to provide support to Peace 911, namely:

SECTION 7. COORDINATION WITH NATIONAL GOVERNMENT AGENCIES. Peace 911 pursuant to EO 70 shall coordinate with relevant national government agencies in the implementation of programs and projects. This includes coordination with agencies under the National Task Force to End Local Communist Armed Conflict formed through EO 70.

SECTION 8. ADHERENCE TO MEMORANDUM CIRCULAR NO. 2019-125, SERIES OF 2019 BY THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT. The City Government adheres to the provisions of the guidelines for the local government units in the implementation of EO 70 (Memorandum Circular No. 2019-125, Series of 2019).


SECTION 9. FUNDING. All expenses necessary and incidental to the effective implementation of the operations of PEACE 911 and ensure the successful implementation of this Order, shall be charged to the Office of the City Mayor or funds made available for the purpose by the City Mayor.

SECTION 10. SEPARABILITY. In the event that any provision of this Order or any part hereof is declared invalid, illegal or unconstitutional, the provisions not hereby affected shall remain in force and effect.

SECTION 11. REPEAL. All orders, rules and regulations and other issuance or parts thereof that are inconsistent with the provisions of this Order, are hereby repealed or modified accordingly.

SECTION 12. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
