**AN ORDER DEFINING VULNERABLE AGE AND VULNERABLE SECTOR  
FOLLOWING THE PROVISIONS OF IATF RESOLUTION NO. 79**

**WHEREAS**, the World Health Organization (WHO) has declared a COVID-19 pandemic;

**WHEREAS**, President Rodrigo Duterte issued Presidential Proclamation 1021 extending the State of Calamity in the country until September 12, 2021;

**WHEREAS**, the Inter-Agency Task Force (IATF) issued Resolution No. 79 dated October 15, 2020;

**WHEREAS**, Letter A of the same Resolution No. 79 provides, "Age-based stay-at-home restrictions are hereby adjusted to include only those who are under fifteen (15) years of age, as well as those over sixty-five (65) years. Provided that local government units retain the authority to impose a higher age limit for minors depending on the COVID-19 situation in their respective jurisdictions. Provided finally that this shall not be interpreted to mean that restrictions imposed by various prevailing community quarantine classifications for the general population are lifted."

**WHEREAS**, there is a need to define the inclusive age of the vulnerable sector;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, THAT I, SEBASTIAN Z. DUTERTE**, Acting Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. VULNERABLE AGE.** Individuals that are below 18 years old and above 65 years old.

**SECTION 2. VULNERABLE SECTOR.** Individuals below 18 years old and above 65 years old, those with immunodeficiency, co-morbidity, other serious health risks and pregnant women.

**SECTION 3. SEPARABILITY CLAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 4. REPEALING CLAUSE.** All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 5. EFFECTIVITY.** This Order shall take effect immediately.
