**"AN ORDER CREATING THE TECHNICAL WORKING GROUP FOR THE
DRAFTING OF THE IMPLEMENTING RULES AND REGULATIONS
OF CITY ORDINANCE NO. 0729-19"**

WHEREAS, Article XV, Section 3 (2) of the 1987 Philippine Constitution states that the State shall defend the right of children to special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development;

WHEREAS, the 18th City Council of the City of Davao passed Ordinance No. 0729-19, otherwise known as "An Ordinance Establishing a Transformative Program for Children at Risk";

WHEREAS, the same ordinance provides that a technical working group shall be formed to draft the Implementing Rules and Regulations;

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of Davao City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION AND COMPOSITION OF THE TECHNICAL WORKING GROUP. The Technical Working Group is hereby created and shall be composed of the following persons and/or heads of the following offices:

1. City Mayor;
2. Committee on Peace and Public Safety;
3. Committee on Women, Children and Family Relations;
4. Davao City Police Office;
5. Liga ng mga Barangay;
6. City Social Welfare and Development Office;
7. Council for the Welfare of Children; and
8. Davao City Special Office for Children's Concern.

SECTION 2. DUTIES AND RESPONSIBILITIES. The Technical Working Group shall draft the Implementing Rules and Regulations of Ordinance No. 0729-19, otherwise known as "An Ordinance Establishing a Transformative Program for Children at Risk".

SECTION 3. SECRETARIAT. The Board shall also have a Secretariat which shall be the City Social Welfare and Development Office. It is tasked to handle all administrative and/or secretarial related activities. It shall ensure all meetings of the Board are effectively organized and recorded.

SECTION 4. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 5. REPEALING CLAUSE. All previous Executive Orders inconsistent with this Executive Order are hereby repealed or modified accordingly.

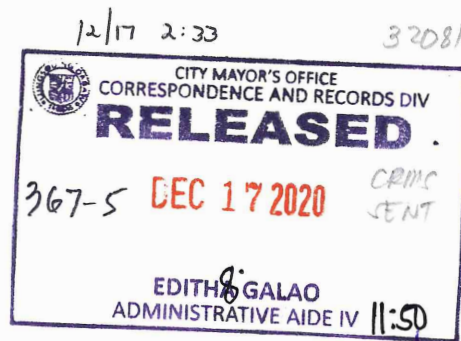
SECTION 6. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
