EXECUTIVE ORDER NO. 5
Series of 2022

**AN ORDER PROVIDING FOR THE LIFTING OF THE MODIFIED LIQUOR BAN
IN DAVAO CITY**

WHEREAS, the World Health Organization (WHO) has declared a COVID-19 pandemic;

WHEREAS, President Rodrigo Duterte issued Presidential Proclamation 1218 series of 2021, dated September 10 2021, extending the State of Calamity in the country until September 12, 2022;

WHEREAS, the Inter-Agency Task (IATF) Resolution No. 159-A, dated January 29, 2022, placed Davao City under Alert Level 3 status effective February 1, 2022 until February 15, 2022;

WHEREAS, Davao City is currently at 85.14% for first doses, 83.31% for second doses, and 15.26% for booster shots of 80% of the city's total population as reported by the Davao City Task Force on Covid-19 on February 14, 2022;

WHEREAS, the City Government of Davao has procured the Molnupiravir antiviral drug as treatment for mild and moderate Covid-19 cases for referral hospitals and Temporary Treatment and Monitoring Facilities (TTMFs) in the city;

WHEREAS, there is a need to ease and loosen restrictions following the decrease in the number of cases reported, the active vaccination rollout within the city, and the availability of the Molnupiravir drug.

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. LIFTING OF THE BAN. The Order Providing for the Modified Guidelines on Liquor Ban as reflected in Executive Order No. 59 series of 2021 and amended through Executive Order No. 1 series of 2022 is hereby lifted.

SECTION 2. IMPLEMENTATION OF ORDINANCE. Ordinance No. 004-13 Series of 2013, or an Ordinance Amending Ordinance No. 1627, Series of 2014, "An Ordinance Regulating the Operation of Business Establishments Selling Liquors, Coconut Wine and Other Nature Wine and Other Alcoholic Beverages in the City of Davao" shall be implemented. The selling, serving, or consuming of liquor and any other alcoholic or intoxicating drinks in public shall be prohibited from 1:00 in the morning (1:00 A.M.) to 8:00 in the morning (8:00 A.M.)

SECTION 3. CONSUMPTION. The prohibition on the serving of liquor in restaurants, bars, videokes, hotels, and all other establishments open to the public is hereby lifted.


SECTION 4. BAN. Drinking liquor in parks, roads, streets, alleys, pathways, and similar areas continue to be prohibited.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

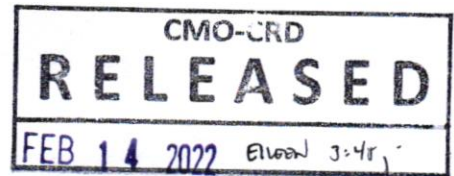
SECTION 7. EFFECTIVITY. This Order shall take effect at 12:01AM on February 15, 2022.
