**EXECUTIVE ORDER NO. 45**

**AN ORDER CREATING THE LOCAL INVESTMENT PLANNING FOR HEALTH  
(LIPH) / ANNUAL OPERATIONAL PLAN (AOP) PLANNING TEAM**

**WHEREAS**, Article II, Section 15 of the 1987 Constitution states that "the State shall protect and promote the right to health of the people and instill health consciousness among them";

**WHEREAS**, Article XIII, Section 11 of the 1987 Constitution states that "the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers";

**WHEREAS**, Section 3.1b under General Objectives of Republic Act No. 11223, also known as the "Universal Health Care Law" seeks to "ensure that all Filipinos are guaranteed equitable access to quality and affordable health care goods and services and protected against financial risk";

**WHEREAS**, Section 22.1 of Republic Act No. 11223 states that the national government, through the Department of Health, shall make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health, health commodities, and such other management support and technical assistance, to improve the functionality of the province-wide and city-wide health systems;

**WHEREAS**, Section 22.3 of Republic Act No. 11223, further states that the province-wide and city-wide health investment plans like the LIPH, and the annual operational plan (AOP) shall serve as the basis for the grants from the national government to account for complementation of public and private health care providers and public or private health sector investments to national investment plans;

**WHEREAS**, Department of Health Administrative Order No. 2020-0022, Guidelines on the Development of Local Investment Plans for Health Section V. General Guidelines A.3 states that the LIPH shall be developed by every LGU based on the local health epidemiology and situation, local objectives for health, and guided by the Ambisyon Natin 2040, Sustainable Development Goals (SDG), Philippine Development Plan (PDP) and the National Objectives for Health (NOH);

**WHEREAS**, Section V-B.2 of the same Administrative Order states that "the LIPH shall be translated into three Annual Operational Plans (AOPs)";

**WHEREAS**, Section C.1 and C.2 of the same Administrative Order states that the AOPs shall be considered by the DOH in its yearly budget proposals, with appropriate

feedback provided to LGUs and shall be the basis of financial and non-financial grants from the National Government, particularly DOH, and other health partners;

**WHEREAS**, Section VI.A.1 of the same Administrative Order states that to ensure the development, implementation, monitoring and evaluation of the LIPH, an LGU planning team shall be organized;

**NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE**, Mayor of Davao City, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CREATION.** There is hereby created a Local Investment Planning for Health Planning Team, otherwise known as LIPH Planning Team.

**SECTION 2. COMPOSITION OF LIPH PLANNING TEAM** The LIPH Planning Team shall be composed of the following:

Chairman:	City Health Officer
Vice-Chairman:	Chairperson, Committee on Health, Sangguniang Panlungsod
Members:	City Planning and Development Officer
	Human Resources and Management Officer
	City Budget Officer
	City Accountant
	City Treasurer
	President, Liga ng mga Barangay
	Representative from Indigenous Cultural
	Communities/Indigenous Peoples (ICC/Ips)
	Representative from Non-Government Organization/Civil
	Service Organizations (NGOs/CSOs)

**SECTION 3. FUNCTIONS OF THE LIPH PLANNING TEAM** The LIPH Planning Team shall have the following functions:

1. Develop Local Investment Plan for Health that shall be translated into three Annual Operational Plans (AOPs).
2. Ensure the implementation of the Local Investment Plan for Health and the translated Annual Operational Plans (AOPs).

**SECTION 4. DEVELOPMENT OF THE LIPH AND AOP.** The development of the LIPH and AOP shall follow an iterative process as stated in Department of Health Administrative Order No.2020-0018 VI.B:

- A. Center for Health Development (CHD) call to plan;
- B. LGU Plan Development
- C. Review and appraisal
- D. Concurrence of plan
- E. Plan implementation; and
- F. Monitoring of plan implementation.

**SECTION 5. GUIDELINES ON THE DEVELOPMENT OF LOCAL INVESTMENT PLAN FOR HEALTH.** The LIPH Planning Team shall follow the specific guidelines stated in Department of Health Administrative Order No. 2020-0022 – Guidelines on the Development of Local Investment Plans for Health.

**SECTION 6. FUNDING AND OPERATING COSTS.** All costs pertaining to the operations of the LIPH Planning Team shall be chargeable against available funds and resources of the City Health Office, subject to the usual accounting and auditing rules and regulations.

**SECTION 7. SEPARABILITY CLAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 8. REPEALING CLAUSE.** All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

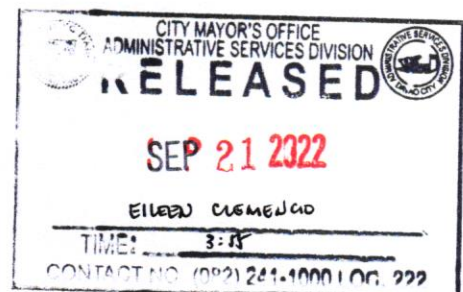
**SECTION 9. EFFECTIVITY.** This Order shall take effect immediately.
