## EXECUTIVE ORDER NO. 6 Series of 2022

## AN ORDER RECONSTITUTING THE COMPOSITION OF THE EXECUTIVE BOARD, THE INFRASTRUCTURE MONITORING TEAM, THE TECHNICAL WORKING GROUP (TWG) AND THE SECRETARIAT OF THE DAVAO FOOD TERMINAL COMPLEX (DFTC), AMENDING EXECUTIVE ORDER NO. 08, SERIES OF 2017

**WHEREAS,** Davao City recognizes its potential and role as the premier agricultural and trade center in Mindanao, and as a result thereof, has provided in its Comprehensive Development Plan the establishment of trade facilities with appropriate marketing strategies within and outside the city. As such, it envisions the establishment of the Davao Food Terminal Complex, or an agricultural trading facility which will ensure the achievement of such aspirations;

**WHEREAS**, Special Order No. 369 issued on August 16, 2010 by the Department of Agriculture, provides for the establishment of such facility, called the Agri-Pinoy Trading Center (APTC). Pursuant thereto, the City Government of Davao was one of the few selected recipients of the funding for the establishment of the said agricultural trading facility for the benefit of farmers in its locality;

**WHEREAS,** in partnership with the National Development Company (NDC) and the Department of Agriculture (DA), the Davao Food Terminal Complex (DFTC), the formal APTC in the city was constructed at Barangay Daliao, Toril, Davao City with the end view of providing the best environment for farmers as well as serving as a consumer trading area of agricultural products;

**WHEREAS**, the Sangguniang Panlungsod of Davao City issued Ordinance No. 0823-21, Series of 2021 – "An Ordinance Declaring the Davao Food Terminal Complex (DFTC) as the Official Wholesale Facility for Fruits and Vegetables and Establishing Guidelines, Rules, and Regulations for the Management and Operation of DFTC in Daliao, Toril, this City";

**WHEREAS,** Section 18 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes LGUs to establish an organization that shall be responsible for the efficient and effective implementation of their development plans, programs, objectives, and priorities;

**WHEREAS,** there is a need to reconstitute the Management and Structure of the DFTC, consistent with the provisions of Ordinance No. 0823-21, Series of 2021, and amending Executive Order No. 08, Series of 2017 – An Order Creating the Davao Food Terminal Complex Executive Committee, Defining its Powers, Functions, and Duties;

**NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE,** Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CREATION AND COMPOSITION**. The Davao Food Terminal Complex Executive Board is hereby created and shall be composed of the following persons and/or heads of the following offices, to wit:

SECTION 2. DUTIES AND RESPONSIBILITIES OF THE DFTC-EXECUTIVE

**BOARD**. The DFTC Executive Board shall primarily undertake the following duties and responsibilities, to wit:

- a. Evaluate and approve proposals for the Business Plan and Operation Manual for the DFTC.
- b. Regularly monitor and oversee the operation and maintenance of the DFTC;
- c. Ensure that the operation of the DFTC remains consistent with its intended purpose, which among others, is the improvement of the farmers and consumer trading market, and;
- d. Recommend policies to appropriate authorities to ensure the efficient operations of the DFTC.

**SECTION 3. INFRASTRUCTURE MONITORING TEAM**. There is hereby created an Infrastructure Monitoring Team primarily tasked to ensure the effective planning, design and construction of the DFTC to be composed of the following persons, to wit:

**SECTION 5. DUTIES AND RESPONSIBILITIES OF THE DFTC TWG**. The DFTC-TWG shall perform the following duties and responsibilities, to wit:

- a. Recommend ways and assist in the formulation of the Business Plan and Operations Manual of the DFTC;
- b. Implement mechanisms to organize and strengthen farmer organizations;
- c. Conduct geographic survey and map out farming areas;
- Increase capacity of farmers and sustain capability through technology information, Good Agricultural Practices (GAP), organic farming, inputs/ resources and skills;
- e. Plan and develop advocacy materials, strategies and conduct advocacy and Information, Education, Communication (IEC) campaigns to the farmers as well as the community and institutional buyers in order to ensure that the objectives of the DFTC are achieved;
- f. Assist in the operationalization of the DFTC and regularly conduct monitoring and coordination meetings and submit reports.

**SECTION 6. SECRETARIAT**. The City Agriculturist's Office is hereby directed to recommend from among its personnel a Secretariat of the DFTC Executive Board and the DFTC TWG. The DFTC Secretariat shall be primarily responsible for all clerical functions, secretarial and administrative undertakings both of the DFTC Executive Board and the DFTC TWG.

For this purpose, the City Administrator is hereby authorized to issue appropriate memoranda to formally constitute the same.

**SECTION 7. FUNDING AND OPERATING COSTS.** All the maintenance and operating costs pertaining to the operation of the ad hoc entities created in the herein executive order including the payment of honoraria, incidental, operating and other expenses shall be undertaken from the available funds of the City Government of Davao, subject to the usual accounting and auditing rules and regulations.


**SECTION 8. SEPARABILITY CLAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 9. REPEALING CLAUSE.** All other orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY. This Executive Order shall take effect immediately.
