EXECUTIVE ORDER NO. 32

AN ORDER CREATING THE DAVAO CITY ALLIANCE FOR OUT-OF-SCHOOL YOUTH DEVELOPMENT COUNCIL AND PROVIDING FUNDS FOR THE PURPOSE

WHEREAS, Section 13, Article II of the 1987 Philippine Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Section 5 of Republic Act No. 11510 - An Act Institutionalizing the Alternative Learning System in Basic Education for Out-Of-School Children in Special Cases and Adults and Appropriating Funds Therefor, provides opportunities for out-of-school youth and adult learners to develop basic and functional literacy skills, and to access equivalent pathways to complete basic education;

WHEREAS, the City Government of Davao recognizes the need to provide opportunities to its youth sector, specifically to improve Out-of-School Youth (OSY) access to better education, employment and livelihood support, and other youth development initiatives especially on second chance education, workforce readiness, and positive youth development;

WHEREAS, it is a priority of the City Government to give OSY access to continuing education, workforce readiness, and positive youth development for all deserving out-of-school youth;

WHEREAS, the City Government, together with the private sector, government and non-government agencies, and youth organizations, recognizes the importance of strengthening out-of-school youth development and integrating other OSYs related development programing through institutionalizing this intervention into a council;

WHEREAS, the Davao City Alliance for Out-of-School Youth Development Council (DCAOSYDC) shall serve as the integrating body to institutionalize the participation of all sectors in identifying the appropriate interventions for OSYs through policies, planning, direction-setting, mobilizing resources, implementation and monitoring and evaluation to support OSY programs and services;

WHEREAS, the identified stakeholders and partners, recognizing the relevance of the youth development alliance as the mechanism to reduce the current problems and issues encountered by the OSYs, have agreed to work closely with the city government to ensure a pro-active and responsive Davao City Alliance for Out-of-School Youth Development Council.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law do hereby issue this Order creating the Davao City Alliance for Out-of-School Youth Development Council, to be composed of the following:

SECTION 1. COMPOSITION.

SECTION 2. DUTIES AND FUNCTIONS. The Davao City Alliance for Out-of-School Youth Development Council shall have the following duties and functions:

- a. Make an inventory of the respective members offices' programs which can benefit the OSY in the City;
- b. Formulate policies, strategies, programs and plan of activities and mobilize resources to support the education, employment, entrepreneurship or livelihoods and engagement of Out-of- School Youth; and
- Enter into an agreement to forge partnerships among and with other institutions or entities that have relevant projects to ensure the institutionalization of Out-of-School Youth Development Programs in the City;
- d. Identify and mobilize the prospective OSY learners.

SECTION 3. SECRETARIAT. The City Administrator's Office shall serve as the Secretariat of the DCAOSYDC, with the following duties and functions:

- a. Provide secretariat service, prepare meetings and agenda, and document the proceedings of the meetings and related activities of the Alliance;
- Facilitate the preparation of reports for consolidation, and their timely submission to DCAOSYDC, and the other concerned office and/or agencies; and
- c. Do other related functions deemed necessary for the effective implementation DCAOSYDC.

SECTION 4. MEETINGS. The DCAOSYDC shall meet once a month or as often as necessary as may be determined by the Chairperson.

SECTION 5. FUNDING AND OPERATING COSTS. All costs pertaining to the meetings and activities of the council shall be charged to available funds of the City Mayor's Office, subject to the usual accounting and auditing rules and regulations.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All other orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately.
