EXECUTIVE ORDER NO. <u>10</u> Series of 2023

AN ORDER CREATING A TECHNICAL WORKING GROUP (TWG) TO CRAFT THE IMPLEMENTING RULES AND REGULATIONS OF ORDINANCE NO. 0599-21 SERIES OF 2021 AND TO SPECIFY THE MECHANICS REQUIRING ALL ACCREDITED MOTORCYCLE DEALERS AND DISTRIBUTORS IN DAVAO CITY TO SECURE FROM THEIR CLIENTS A BASIC MOTORCYCLE TRAINING COURSE CERTIFICATE OF COMPLIANCE PRIOR TO THE RELEASE OF THE PURCHASED MOTORCYCLES

WHEREAS, Article II, Section 5 of the 1987 Philippine Constitution provides that "the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy";

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 states in part that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, there is a need to curtail the incidence and prevalence of death and injuries, damage to properties, and socio-economic attributed to road accidents and in recognition of the imminent need to promote a proactive road safety program;

WHEREAS, Davao City Ordinance No. 0599-21 Series of 2021, provides for the creation of a Technical Working Group (TWG) to specify the details of the training mechanics requiring all accredited motorcycle dealers and distributors in Davao city to secure from their prospective clients a certificate of compliance of basic motorcycle training course prior to releasing the purchased motorcycles;

WHEREAS, it is essential for motorcycle dealers and distributors to undergo mandatory basic training course to equip them with the proper knowledge on traffic rules which will eventually lessen the possibility of fatal crashes. This shall also ensure the safety of motorists and pedestrians as well as an efficient flow of traffic in the city.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION OF THE TECHNICAL WORKING GROUP (TWG). There is hereby created a Technical Working Group that will specify the details of the

training mechanics requiring all accredited motorcycle dealers and distributors in Davao City to secure from their prospective clients a certificate of compliance of basic motorcycle training course prior to releasing the purchased motorcycles.

SECTION 2. COMPOSITION. The Technical Working Group shall be composed of the following:

- Technical Education and Skills Development Authority (TESDA) Regional Office XI
- Land Transportation Office (LTO)
- Highway Patrol Group Philippine National Police Region XI
- Davao Crocodile Park Inc.
- Public Safety and Security Office (PSSO)

SECTION 3. DUTIES AND FUNCTIONS. The Technical Working Group shall perform the following functions:

- 1. Craft the Implementing Rules and Regulations (IRR) of City Ordinance No. 0599-21 Series of 2021.
- 2. Specify the details of the training mechanics of the program.

SECTION 4. FUNDING/OPERATING COSTS. All costs pertaining to the operation of the Technical Working Group shall be taken from the available funds of the City Government of Davao subject to the usual accounting and auditing rules and regulations.

SECTION 5. SEPARABILITY CLAUSE. If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.

SECTION 6. REPEALING CLAUSE. All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified.
