**"AN ORDER CREATING THE DAVAO CITY IRONMAN 2023 EXECUTIVE COMMITTEE"**

**WHEREAS**, with the restrictions brought about by the COVID-19 pandemic easing, there is a need for the City Government of Davao (City Gov't.) to renew, spur, and ramp-up economic activities;

**WHEREAS**, the City Gov't. has proven that with the staging of world-class events, Davao City has been effectively put on the map as a premiere destination, not only in the country but all throughout the world; and with this, local economy has greatly benefited;

**WHEREAS**, one of the major events in Davao City which provided tremendous positive effects in the community was the staging of the "Ironman 70.3 Davao" in the years 2018 and 2019; and recently the said event has again been successful procured by the City Gov't. to continue to propel sports development, promote tourism, and spur economic activities, not only in Davao City and its nearby localities, but also for the entire country as well;

**WHEREAS**, for this year 2023, after conferring with the owner-organizer of the Ironman event, it has been agreed that the Ironman 70.3 Davao shall be staged on March 26, 2023 with provisions to allow for the conduct of smaller and other promotional activities or events leading to the said date;

**WHEREAS**, in order to ensure the success of the staging of the Ironman 70.3 Davao and its ancillary activities and events, there is a need to constitute, organize, and create a committee composed of national, as well as local government departments and offices, private sector individuals, groups and organizations;

**WHEREAS**, Section 18 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", authorizes local government units to establish an organization that shall be responsible for the efficient and effective implementation of its development plans, programs, objectives and priorities;

**NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE**, City Mayor of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CREATION AND COMPOSITION.** The **DAVAO CITY IRONMAN 2023 EXECUTIVE COMMITTEE ("Ironman-Execom "** for brevity) is hereby created and shall be composed by the following persons and/or offices:

The members of the **Ironman-Execom** are hereby directed to name their respective permanent alternate representatives who shall take their place in case of their absence.

**SECTION 2. FUNCTIONS.** The **Ironman-Execom** shall perform the following functions, to wit:

- a. Ensure the smooth coordination of all activities relating to the Ironman Davao City Event.
- b. Encourage both public and private sector participation;
- c. Perform such other acts that are necessary to effectively and meaningfully carry out all the Ironman Davao City and its ancillary events.

**SECTION 3. SUPPORT.** All government offices, including private organizations and establishments, are enjoined to extend support to the **Ironman-Execom** for the efficient staging of the Ironman 70.3 Davao event.

The City Administrator is hereby given the authority to identify other person/s or entities who may be required or allowed to perform and provide support, duties and functions for the successful conduct of the Ironman 70.3 Davao.

**SECTION 4. SECRETARIAT.** The City Tourism Operations Office shall serve as the **Ironman-Execom** Secretariat tasked to handle all administrative and secretarial activities of said committee.

**SECTION 5. OPERATIONAL EXPENSES AND FUNDING.** All operating expense, including incidental expenses relative to the services rendered by the members of the committees and other personnel, in addition to their duties and responsibilities and for the work beyond office hours, shall be chargeable against the funds of the City Gov't. and private sector sponsorships, if any, subject to the government accounting and auditing rules and regulations.


**SECTION 6. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 7. REPEALING CLAUSE.** All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 8. EFFECTIVITY.** This Executive Order shall take effect immediately.

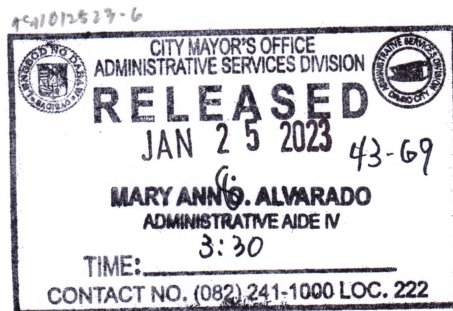
