EXECUTIVE ORDER NO. \mathcal{OP} Series of 2023

AN ORDER PROVIDING FOR THE TEMPORARY CLOSURE OF THE DAVAO CITY-PANABO CITY ROAD FROM THE INTERSECTION OF J.P. LAUREL AVENUE AND R. CASTILLO ST. UP TO THE BOUNDARY OF DAVAO CITY AND PANABO CITY (LASANG) AND THE NORTHBOUND LANE FROM THE INTERSECTION OF J.P. LAUREL AVENUE AND R. CASTILLO ST. UP TO F. TORRES ST. AND R. CASTILLO ST. ON VARIOUS DATES

WHEREAS, Section 21 of Republic Act No. 7160, otherwise known as the Local Goverment Code of 1991, authorizes the local chief executive to temporarily close both national and local roads for athletic events that the local government unit concerned has sponsored, recognized, or approved;

WHEREAS, Davao City is the official sponsor of the following events: 1.) IRONGIRLS, 2.) IRONKIDS, and 3.) the "ALVEO IRONMAN 70.3 Davao Powered by Petron", a duly licensed and sanctioned triathlon event of the World Triathlon Corporation, to be held from March 24-26, 2023 in the cities of Davao, Panabo, Tagum, and the Municipality of Carmen;

WHEREAS, the said events are part of the sports development and tourism promotions of Davao City which will showcase its scenic sights, hospitable people, and abundant culture to the world.

WHEREAS, in order to ensure the succesful staging of the said events and ensure public safety and security, the temporary closure of some roads in Davao City is required.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. ROAD CLOSURE. There shall be a TEMPORARY CLOSURE of the following roads, specifically during the dates and times herein below respectively provided, to wit:

> For the **IRONGIRLS** event on **March 24, 2023, Friday**:

- 4:00 P.M 8:00 P.M (ROAD CLOSURE) R. Castillo St., NORTHBOUND lane only (going to Lanang) from corner Azuela Cove to corner San Nicolas Road (Techno-Trade Resources Davao)
- SOUTHBOUND lane (going downtown) shall remain OPEN to be utilized for two-way traffic;
- > For the **IRONKIDS** event on **March 25, 2023, Saturday**:
 - 5:00 A.M- 9:00 A.M (ROAD CLOSURE) R. Castillo St., NORTHBOUND lane only (going to Lanang) from corner Azuela Cove to corner Jerome St. Page 1 of 2



- SOUTHBOUND lane (going downtown) shall remain OPEN to be utilized for two-way traffic;
- > For the **IRONMAN 70.3** event on **March 26, 2023, Sunday**:

BIKE COURSE

- 3:00 A.M-10:30 A.M (ROAD CLOSURE) SOUTHBOUND lane (going downtown) from Azuela Cove to Lasang (to Panabo-Tagum)
- 10:30 A.M the SOUTHBOUND lane will be opened for vehicular traffic AFTER THE BIKE COURSE.
- 3:00 A.M-12:30 P.M (ROAD CLOSURE) Northbound lane from Azuela Cove to Lasang.
- 12:30 P.M NORTHBOUND lane shall be opened for vehicular traffic.

RUN COURSE

- 3:00 A.M-3:30 P.M **(ROAD CLOSURE)** NORTHBOUND lane (going to Lanang) from corner J.P. Laurel Ave./F.Torres St., to Azuela Cove (J.P. Laurel Ave./ R. Castillo Jct.)
- SOUTHBOUND lane (going downtown) shall remain OPEN to be utilized for two-way traffic.

SECTION 2. REMINDERS. All persons affected hereby are advised to plan their trips ahead or use available alternative routes or amend their schedules as may be deemed appropriate.

All national and local government offices in Davao City are hereby enjoined to provide full and active support and their utmost cooperation for the successful staging of all the foregoing events.

SECTION 3. EFFECTIVITY. This Executive Order shall take effect immediately and shall last until the affected roads will be reopened to traffic by appropriate authorities.
