### EXECUTIVE ORDER NO. 14

## AN ORDER CONSTITUTING THE MEMBERSHIP OF THE CITY STATISTICS COMMITTEE AND DEFINING ITS FUNCTIONS

**WHEREAS**, the Philippine Statistics Authority (PSA) is mandated through Republic Act No. 10625, also known as the Philippine Statistical Act of 2013, to coordinate with Local Government Units (LGUs) on the promotion and adoption of statistical standards involving techniques, methodologies, concepts, definitions and classifications, and on the avoidance of duplication in the collection of statistical information;

**WHEREAS,** the PSA Board Resolution No. 05, series of 2015 established the Regional Statistics Committees (RSCs) to provide direction and guidance on statistical matters and institute coordinative mechanisms at the regional and local levels;

**WHEREAS,** the Regional Development Council (XI) Resolution No. 08, Series of 2019, states that there is a need to establish a City Statistics Committee (CSC) for a well-coordinated statistical system at the sub-regional and city level as coordinator in improving the statistical system that is responsive to development planning and monitoring;

**WHEREAS,** there is a need to constitute the membership of a City Statistics Committee in order to conform to the above-stated statistics mechanisms and statistics-related issuances.

**NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE,** Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CONSTITUTION AND COMPOSITION.** There is hereby constituted a Davao City Statistics Committee which shall be composed of the following members, to wit:

## **SECTION 2. FUNCTIONS.** The Committee shall perform the following functions:

- 1. Replicate the functions of the RSC at the city level and serve as clearing house for all statistics generated in the city;
- 2. Serve as coordinator in improving the statistical system that is responsive to development planning and monitoring;
- 3. Be the recommendatory body on the statistical policies and programs of the city;
- 4. Exercise autonomy in discharging their functions and responsibilities and in making decisions to address statistical issues at the city level.

**SECTION 3. SECRETARIAT.** The Secretariat shall be headed by the Philippine Statistics Authority-Davao, which shall be responsible for providing technical and administrative support to the CSC.

**SECTION 4. OPERATING EXPENSES.** The budgetary requirements of the City Statistics Committee shall be sourced from the General Fund-Lump Sum Appropriations of the City Government of Davao.

**SECTION 5. SEPARABILITY CAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 6. REPEALING CAUSE.** All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 7. EFFECTIVITY.** This Order shall take effect immediately.
