**AN ORDER CREATING A TECHNICAL WORKING GROUP FOR THE  
IDENTIFICATION OF LOT BOUNDARIES ADJACENT TO THE DAVAO CITY  
COASTAL BYPASS ROAD**

**WHEREAS**, Section 18 of Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, authorizes local government units to establish an organization that shall be responsible for the efficient and effective implementation of their development plans, programs, objectives, and priorities;

**WHEREAS**, the Davao City Coastal Bypass Road Project is a project of the Department of Public Works and Highways which was started in 2017 which shall serve as a bypass road occupying the shoreline connecting Toril and Magsaysay Park;

**WHEREAS**, the Coastal Road shall start at Junction Davao-Cotabato Road passing through the coastal lines of Junction Bago Aplaya and going through Talomo Proper, Matina Aplaya (Times Beach), Roxas Avenue Section to Sta. Ana Wharf and then to R. Castillo Street in Agdao. The estimated total length is 18.633 kilometers. The project is divided into four (4) segments: Segment A – Bago Aplaya-Times Beach; Segment B – Times Beach-Roxas Avenue; Segment C – Roxas Avenue-Sta. Ana Wharf; and Segment D – Sta. Ana Wharf-R. Castillo;

**WHEREAS**, the City Government of Davao and the Philippine Reclamation Authority (PRA) signed a Memorandum of Understanding last January 25, 2023 to undertake the reclamation and land development of more or less 57.3012 hectares enclosed by the Davao City Coastal Bypass Road Project;

**WHEREAS**, there is a need to protect and secure reclaimed areas and areas for reclamation in coordination with the PRA;

**WHEREAS**, there is a need to create a technical working group (TWG) to identify lot boundaries adjacent to the Coastal Bypass Road going inland in order to initiate appropriate measures to ensure the safety and security of the residents near the vicinity as well as the general public.

**NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE**, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CREATION AND COMPOSITION.** There is hereby created a Technical Working Group to identify the Coastal Bypass Road boundaries in the City of Davao, which shall be composed of the following persons and/or offices, to wit:

**SECTION 2. DUTIES AND FUNCTIONS.** The Technical Working Group (TWG) to identify lot boundaries adjacent to the Davao City Coastal Bypass Road shall have the following duties and functions, to wit:

1. Identify lot boundaries adjacent to the Davao City Coastal Bypass Road.
2. Provide the expertise and technical support of their office to the TWG and conduct regular meetings as well as provide report as to the status of the TWG's progress.
3. Make appropriate recommendations to the City Mayor and/or the Sangguniang Panlungsod for the next measures to be undertaken.
4. Perform such other functions as the City Mayor may order from time to time.

**SECTION 3. SECRETARIAT.** The City Administrator's Office is hereby directed to serve as the Secretariat of the Technical Working Group and shall be tasked to handle all administrative and secretarial functions of the TWG.

**SECTION 4. FUNDING/OPERATING COSTS.** All costs pertaining to the operation of the Technical Working Group shall be charged to available funds of the City Government subject to the usual accounting and auditing rules and regulations.

**SECTION 5. SEPARABILITY CLAUSE.** If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.

**SECTION 6. REPEALING CLAUSE.** All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

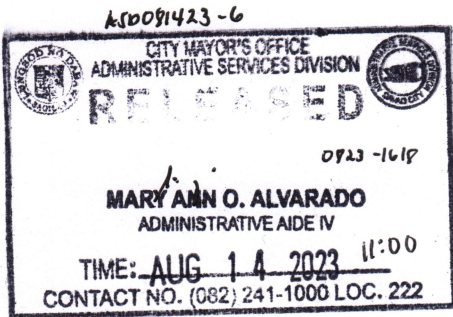
**SECTION 7. EFFECTIVITY.** This Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified.
