EXECUTIVE ORDER NO. 22

AN ORDER RECONSTITUTING THE DAVAO CITY LOCAL SCHOOL BOARD (LSB)

WHEREAS, Section 98 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that there shall be established in every province, city or municipality a provincial, city or municipal school board;

WHEREAS, the same code provides for the composition of the Local School Board (LSB);

WHEREAS, each Local School Board is tasked to determine the annual supplemental budgetary needs for the operation and maintenance of public schools within their respective locality;

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local School Board, as follows:

SECTION 1. COMPOSITION. The membership of the Davao City Local School Board (LSB) shall be composed of the following:

Chairperson

City Mayor

Co-Chairperson

Davao City Schools Division Superintendent,

Department of Education

Members

- Chairperson, Sangguniang Panlungsod Committee on Education, Science and Technology
- City Treasurer
- Representative of the Sangguniang Kabataan Federation in the Sangguniang Panlungsod
- President of the City Federation of Parents-Teachers Association
- Representative of the Teachers' Organization in the City
- Representative of the Non-Academic Personnel of Public Schools in the City

In the exigency of public service and in case of absence of the Chairperson, the City Administrator shall assume the former's duties and functions in the LSB. All the above-named offices and/or persons named as members in the herein section are also hereby directed to further name their alternate permanent representatives to the LSB who shall take their place in case of their absence.

The Chairperson or authorized representative shall identify appropriate personnel to comprise the technical staff of the LSB.

SECTION 2. DUTIES AND FUNCTIONS. The LSB shall exercise the following functions as mandated in Section 99 of RA 7160:

- A. Determine, in accordance with criteria set by the Department of Education, the annual supplemental budgetary needs for the operation and maintenance of public schools within the city, and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenues as laws and ordinances may provide;
- B. Authorize the City Treasurer to disburse funds from the Special Education Fund pursuant to the budget prepared and in accordance with existing rules and regulations;
- C. Serve as advisory committee to the Sangguniang Panlungsod concerned on educational matters such as but not limited to, the necessity for and the uses of local appropriations for education purposes; and
- D. Recommend changes in the names of public schools within the territorial jurisdiction of the City of Davao for enactment by the Sangguniang Panlungsod.

The Department of Education shall consult the LSB on the appointments of division superintendents, district supervisor, school principals and other school officials.

SECTION 3. OPERATIONAL EXPENSES AND FUNDING. All members and personnel who are performing the functions of the LSB are hereby authorized to claim for incidental expenses relative to the services rendered in addition to their duties and responsibilities and for work beyond office hours subject to the usual accounting and auditing rules and regulations chargeable against budgetary allocations of the LSB.

SECTION 4. REPEALING CLAUSE. All the other Executive Orders or issuances inconsistent with the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This order shall take effect immediately.
