EXECUTIVE ORDER NO. 20

AN ORDER CREATING A LOCAL INTER-AGENCY COMMITTEE (LIAC) FOR THE DEVELOPMENT OF THE DAVAO REGIONAL GOVERNMENT CENTER SITE

WHEREAS, Presidential Proclamation No. 1354, Series of 2022 was issued on April 28, 2022 reserving certain parcels of patrimonial land of the government situated in Barangay Bago Oshiro, Davao City and transferring ownership thereof in favor of concerned government agencies and offices for the establishment of the Davao Regional Government Center;

WHEREAS, the proposed development of the Regional Government Center located at Barangay Bago Oshiro aims to provide efficient and effective public service to the constituents of Davao City and neighboring provinces in one convenient location;

WHEREAS, the Regional Government Center has a total area of 3,557,376 square meters subdivided into individual lots for different National Government Agencies as well as for the City Government of Davao, as prescribed in the Site Development Plan prepared by the Department of Public Works and Highways XI and the Department of Environment and Natural Resources XI;

WHEREAS, the Regional Government Center will also have open and green areas, a physical wellness center, recreational areas, drainage lines, power distribution lines, water distribution lines, telecommunication facilities, and the like;

WHEREAS, Section 2(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, declares that "it is likewise the policy of the State to require all national agencies and offices to conduct periodic consultations with appropriate local government units, nongovernmental and people's organizations, and other concerned sectors of the community before any project or program is implemented in their respective jurisdictions";

WHEREAS, the Infrastructure Development Committee (IDC) XI of the Regional Development Council (RDC) through the Subcommittee for the Regional Government Center (SubCom RGC) issued Resolution No.1 Series of 2023 requesting the City Government to issue an Executive Order creating a Local Inter-Agency Committee (LIAC) for the Development of the Regional Government Center Site;

WHEREAS, a Local Inter-Agency Committee (LIAC) shall be created to facilitate coordination and collaboration among various government agencies and organizations at the local level, ensuring effective delivery of resettlement services for the affected informal settler families (ISFs) in the project area.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION AND COMPOSITION. The Local Inter-Agency Committee is hereby created and shall be composed by the following persons and/or heads of the following offices, to wit:

SECTION 2. DUTIES AND RESPONSIBILITIES OF THE LOCAL INTER- AGENCY COMMITTEE. The LIAC for the development of the RGC site is primarily tasked to ensure the successful implementation of the resettlement plan for informal settlers that will be affected by the establishment of the RGC. Specifically, it is tasked to:

- a. Serve as a focal structure for coordination and a clearinghouse for resettlement planning and implementation, monitoring, and evaluation.
- b. Determine/validate the magnitude and scope of resettlement requirements.
- c. Ensure the conduct of appropriate social mapping methods for community and household socio-economic profiling.
- d. Establish guidelines and mechanics for beneficiary selection, arbitration, and award.
- e. Develop a framework for multi-sectoral/multistakeholder participation between civil society organizations, national government agencies, local government units, and the private sector.
- f. Facilitate the conduct of information education and communication (IEC) activities and community consultation, and encourage multi-stakeholders' participation.
- g. Recommend appropriate resettlement packages and other entitlements, if possible, for the affected families.
- h. Formulate a comprehensive resettlement action plan (RAP).
- i. Facilitate the orderly, peaceful, and humane resettlement/transfer of families to their permanent housing.
- j. Monitor and evaluate the implementation of plans, programs, and projects as well as the operations of the sub-committees.
- k. Create subcommittees and identify members for Social Preparation and Resettlement, Resettlement Planning and Implementation, Beneficiary Selection, Arbitration and Awards, Community Development, and Estate Management.

SECTION 3. SECRETARIAT. In order to assist the LIAC for RGC in the discharge of its functions, the secretariat shall be the Housing and Homesite Development Division of the City Planning and Development Office. The secretariat shall be responsible for the documentation of the proceedings, consolidation of reports, and other secretarial works required.

SECTION 4. FUNDING/OPERATING COSTS. All costs pertaining to the operation of the LIAC, incidental expenses and other expenses to its members, secretariat, and other appropriate personnel, as may hereinafter be identified by the Chairperson or the Co-Chairperson or the LIAC, shall be taken from the available funds of the City Government of Davao and from the contributions of the government agencies in the Regional Government Center, subject to the usual accounting and auditing rules and regulations.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately.


