EXECUTIVE ORDER NO. <u>3λ</u> Series of 2023

AN ORDER REORGANIZING AND RECONSTITUTING THE LOCAL PROJECT MANAGEMENT TEAM (LPMT) FOR THE FORMULATION OF THE COMPREHENSIVE LOCAL JUVENILE INTERVENTION PROGRAM OF DAVAO CITY, IDENTIFYING ITS COMPOSITION, DEFINING ITS RESPONSIBILITIES, AND FOR SUCH OTHER PURPOSES

WHEREAS, Local Government Units, such as the City Government of Davao, are mandated under Republic Act No. 9344 as amended by Republic Act No. 10630, to formulate a comprehensive Juvenile Intervention Program (Local Intervention Program) to be instituted from the barangay to the city level;

WHEREAS, the City Government of Davao, under devolved set-up as provided in Republic Act No. 7610 otherwise known as the Local Government Code of 1991, was among the pilot areas for the Localization of the Comprehensive National Juvenile Intervention Program;

WHEREAS, Memorandum Circular No. 2016-68 of the Department of the Interior and Local Government (DILG) enjoins all Local Chief Executives (LCE) to utilize the guidelines for the LGUs on the development of the Comprehensive Local Juvenile Intervention Program (CLJIP);

WHEREAS, in conformity with the provisions of said guidelines, there is a need for the reconstitution and recognition of a Local Project Management Team (LPMT) which shall take charge of the formulation of CLJIP enforceable within the jurisdiction of this city.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me, do hereby order the following:

SECTION 1. RECONSTITUTION. The LPMT for the formulation of the CLJIP of Davao City (LPMT – Juvenile Program) is hereby reconstituted.

SECTION 2. COMPOSITION. Pursuant to the provisions of the guidelines for the development of CLJIP, the LPMT for the formulation of the abovementioned program shall be composed of the Heads or the duly authorized representatives of the following agencies:

- President, Liga ng mga Barangay sa Pilipinas
- City Social Welfare and Development Office (CSWDO)
- City Planning and Development Office
- City Budget Office
- Sangguniang Panlungsod Committee on Women, Children and Family Relations
- Davao City Police Office Women and Children Protection Desk







- Department of the Interior and Local Government (DILG) Davao City Operations Office
- Local Council for the Protection of Children (LCPC)
- Special Office for Children's Concerns
- Integrated Gender and Development Division (IGDD)
- Sangguniang Kabataan (SK) Federation
- City Mayor's Office Peace 911
- Davao City Disaster Risk and Management Office (DCDRRMO)
- Barangay and Cultural Communities Affairs Division (BCCAD)
- Department of Education (DepEd) Schools Division Superintendent XI
- City Health Office (CHO)
- Non-Government Organization (NGO), to be appointed by the City Mayor
- Faith Based Organization (FBO), to be appointed by the City Mayor

The head of office of the **City Social Welfare and Development Office** is hereby designated as the Team Leader of the LPMT-Juvenile Program.

SECTION 3. DUTIES AND RESPONSIBILITIES. The LPMT shall take charge of the formulation of the CLJIP for Davao City. Consequently, the LPMT-Juvenile Program shall have the following duties and responsibilities:

- a. To spearhead the efforts of the city in attaining the objectives of the CLJIP;
- To lead and direct the conduct of social preparation activities such as data gathering, the planning process and the establishment of the Juvenile and Referral System in the City of Davao;
- c. To initiate and refine program planning, designing and implementation;
- d. To plan and oversee the local monitoring and evaluation scheme with the technical assistance and supervision of the national Technical Working Group (TWG) on capacity building and submit annual reports to DILG Central Office through its Regional Office Region XI;
- e. To coordinate and lead the continuing capacity building of the direct service providers like the CSWDO and the Department of Social Welfare and Development (DSWD);
- f. To ensure that inputs from Barangay Councils for the Protection of Children (BCPC) are incorporated in the plans and that monitoring of the project, plans, and activities are undertaken jointly; and
- g. To perform other related work.

SECTION 4. FUNDING. Rule 24.c of the Revised Implementing Rules and Regulations of Republic Act No. 9344 as amended by Republic Act No. 10630, provides that the budget allocation for the development and implementation of the CLJIP shall be sourced from the 1% Internal Revenue Allotment (IRA) allocated for the strengthening and implementation of the programs of the Local Council for the Protection of Children (LCPC) for the Children-at-Risk (CAR) and Children in Conflict with the Law (CICL).

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.


