EXECUTIVE ORDER NO. 33
Series of 2023

AN ORDER RECONSTITUTING THE DAVAO CITY ENHANCED COMPREHENSIVE LOCAL INTEGRATION PROGRAM (E-CLIP) COMMITTEE FOR FORMER REBELS AND FORMER VIOLENT EXTREMISTS

WHEREAS, Article II, Section 5 of the 1987 Philippine Constitution declares that "the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy";

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units with the promotion and maintenance of peace and order, and preservation of public safety;

WHEREAS, Task Force Kalinaw and the Comprehensive Local Integration Program (CLIP) Committee were previously constituted to comply with the directives providing benefits and basic services to rebel returnees as stipulated under Administrative Order No. 172, Series of 2007, and Presidential Executive Order No. 3, Series of 2001, respectively;

WHEREAS, the Department of the Interior and Local Government (DILG) and the Department of National Defense (DND) issued Joint Memorandum Circular No. 2021-01, series of 2021 dated September 22, 2021, which mandates the creation of Local E-CLIP committees in Highly Urbanized Cities (HUCs);

WHEREAS, Ordinance No. 0998-22, series of 2022 – An Ordinance Institutionalizing the Davao City Enhanced Comprehensive Local Integration Program (E-CLIP) for Former Rebels (FRs) and Former Violent Extremists (FVEs) in Davao City and Other Pertinent Programs and Services as Provided by the Halfway House Kalinaw Village, was issued on June 28, 2022 and states the composition of the Davao City E-CLIP;

WHEREAS, the City Government of Davao, in partnership with the DILG and other agencies, established the Kalinaw Village as a temporary shelter facility in Davao City for former rebels and other former violent extremists who have abandoned armed struggle. It serves as a venue where various interventions are undertaken in order to reintegrate the FRs and FVEs into mainstream society;

WHEREAS, there is a need to reconstitute the membership of the Davao City E-CLIP Committee in compliance with the abovementioned issuances.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. RECONSTITUTION OF THE DAVAO CITY E-CLIP COMMITTEE.
The City E-CLIP Committee is hereby reconstituted and shall be composed of the following, to wit:

Chairperson: City Mayor
Co-Chairperson: Commanding Officer, Armed Forces of the Philippines - 1003rd Infantry Brigade

Members: (Heads of the following offices or their duly authorized representatives):

- City Administrator
- Head, City Social Welfare and Development Office (CSWDO)
- Focal Person, Davao City Peace 911
- City Director, Department of the Interior and Local Government - Davao City Operations Office
- City Director, Davao City Police Office
- Chairperson, Sangguniang Panlungsod Committee on Peace and Public Safety
- Chairperson, Sangguniang Panlungsod Committee on Civil, Political and Human Rights
- President, Liga ng mga Barangay
- Representative from each of the following organizations:
 - Civil Society Organizations (CSO)
 - Davao City Chamber of Commerce and Industry Inc. (DCCCII)
 - Former Rebels (FRs) and Former Violent Extremists (FVEs)
 - The Media Sector

The City Mayor, as Chairperson of the City E-CLIP Committee, shall identify and appoint qualified representatives from the media sector and CSO who must be a member of the Davao City Peace and Order Council.

The E-CLIP Committee shall set appropriate parameters for the FRs and FVEs Representative nominee, then unanimously vote and approve in terms of the representation of the FRs and FVEs in the E-CLIP Committee.

SECTION 2. FUNCTIONS OF THE COMMITTEE E-CLIP. The Davao City E-CLIP Committee shall be responsible for the effective implementation and institutionalization of Davao City's E-CLIP. Specifically, the Davao City E-CLIP Committee is tasked to perform the following functions, to wit:

- a. Ensure convergent efforts in the delivery of the identified services of the program including reproduction and dissemination of E-CLIP Information, Education, and Communication (IEC) materials.
- b. Ensure proper documentation and referral of the needs of the FRs and FVEs to appropriate agencies and other partner institutions including profiling of the FRs and FVEs.
- c. Assist the FRs and FVEs in completing the E-CLIP Enrolment Form. The FRs and FVEs should either sign or use their thumb mark after completing the form, and the same must be attested by the DILG and approved by the City Mayor or the City Social Welfare and Development Office.

- d. Assist the FRs and FVEs in the preparation and implementation of their Former Rebel Reintegration Plan (FRRP)/ Former Violent Extremist Reintegration Plan (FVERP) and Business Plan (Mungkahing Proyekto) through the City Social Welfare and Development Office (CSWDO) as the lead office managing the Kalinaw Village. It shall have the option to come up with its customized template (form) of FRRP/FVERP and Business Plan, provided that the minimum datasets reflected in the attached form are considered.
- e. Conduct regular E-CLIP Committee meetings to discuss coordination and monitoring initiatives on E-CLIP implementation in Kalinaw Village, and resolve issues and concerns affecting Kalinaw Village, especially in terms of its interventions, programs, and services for FRs and FVEs, which shall form part of the report to the City Peace and Order Council (CPOC) during its meetings;
- f. Facilitate the processing of the FRs and FVEs birth certificates, identification ID cards/documents, registration to the Philippine Health Insurance Corporation (PHIC), and other necessary documents needed by the partner-stakeholders; and
- g. Coordinate and report to the Department of Justice (DOJ), through Local/Regional Task Forces to End Local Communist Armed Conflict (L/RTFs-ELCAC), the FRs and FVEs who will signify to avail the Amnesty Program, subject to existing laws and policies.

SECTION 3. SECRETARIAT AND TECHNICAL WORKING GROUP. The City Social Welfare and Development Officer is hereby directed to identify appropriate personnel from its office to constitute the City E-CLIP Committee Secretariat and Technical Working Group. They shall perform all clerical and documentation functions attending the operation of E-CLIP. The secretariat shall also be responsible for the calling of meetings, preparation of venues for such, logistical support, taking down of minutes of meetings, and other correspondence and allied functions.

When necessary, the City Administrator may assign and designate other City Government personnel to perform roles and functions relative to and necessary for the proper conduct of all administrative investigations and proceedings.

SECTION 4. MEETINGS. The E-CLIP Committee and Kalinaw Village Management shall meet quarterly or at least four (4) times a year. A special meeting, whenever warranted, may be called for. The agenda shall contain plans, updates, resolution of issues and concerns, and other matters related to the faithful implementation of E-CLIP and the operation of Kalinaw Village which provides interventions and other pertinent assistance and services for the FRs and FVEs in Davao City.

SECTION 5. FUNDING. Subject to compliance with government accounting and auditing rules and regulations, the budgetary needs pertaining to the effective implementation of the E-CLIP, including the payment of honoraria, incidental and other appropriate expenses, as may hereafter be identified, shall be taken from the funds allocated by the national government for the herein purposes.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All other orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

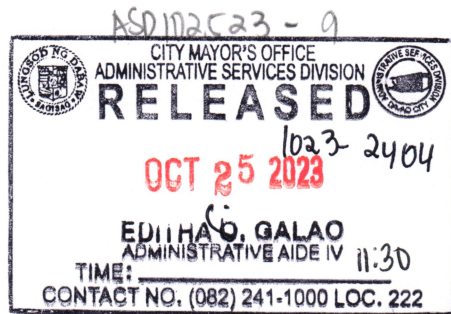
SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately.
